Rucker’s Wholesale and Service Co. Recalls Uncle Buck’s Sunflower Kernel, Uncle Bucks Sweet and Salty mix and Uncle Buck’s Cajun Hot Mix Because Of Possible Health Risk.

Rucker’s Wholesale and Service Co of Bridgeport, IL is voluntarily recalling Uncle Buck’s Sunflower Kernels, Uncle Buck’s Sweet and Salty Mix and Uncle Buck’s Cajun Hot Mix because they have the potential to be contaminated with *Listeria monocytogenes*, an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headaches, stiffness, nausea, abdominal pain and diarrhea, Listeria infection can cause miscarriages and stillbirths among pregnant women.

Uncle Buck’s Sunflower Kernels, Uncle Buck’s Sweet and Salty Mix and Uncle Buck’s Cajun Hot Mix were distributed nationwide into retail farm stores, and outdoor sporting good stores.
